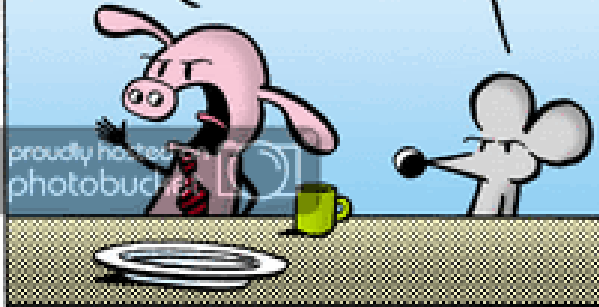
Logical Fallacy of the Day

- ▶ Argument by Gibberish / Jargon
 - ▶ Making / defending an argument by using complicated, confusing words, etc., and acting like you know what you're talking about. This may lead others to believe they are foolish, and thus ought to trust you (fallacious!)

Examples:

Argument Time!
